SECTION-I (ELIGIBILITY PROPOSAL)

Introduction

Roads and Bridges Development Corporation of Kerala Limited (RBDCK) is a corporation established and fully owned by the Government of Kerala and has been incorporated as a limited company under the Companies Act 1956 on 23rd September 1999. RBDCK mainly deals with development of various infrastructure projects like roads, flyovers, Road/Railway Over Bridge(ROB) projects etc including allied works like land requisition, user fee collection etc. Currently RBDCK is dealing with more than 100 projects in various stages.

RBDCK (Company) intends to appoint a law firm(s) as Standing Legal Counsel(s) to represent the Company in legal matters in various courts of law, tribunals etc who shall be responsible for handling with due diligence the legal matters entrusted to them/it from time to time by the Company.

A. Eligibility Criteria

- 1) The Law Firm should be having established offices in Ernakulam.
- 2) The Law Firm should have acted as legal counsel for Public Sector Companies preferably in construction.

- 3) The Law Firm should have completed operation for a minimum of 7 (seven) years since its inception/formation, in rendering services as legal counsel and should have experience in handling Civil, Criminal, Service, Taxation laws, Labour Laws, Land Acquisition Laws and other relevant laws applicable to Public Sector Companies (preferably in construction sector but not mandatory).

- 5) The Law Firm should have an average annual turnover of not less than Rs. 10.00 lakhs (Rupees Ten Lakhs only) for the past 3 (three) years (i.e. FY 2017-18, 2016-17 & 2015-16) and a certificate to this effect should be submitted from the Auditor of the Firm.
- 6) The Law Firm should have minimum one partner supported by minimum 4 Sr. Associate/Associates as legal professionals who have experience preferably in construction sector projects and who are able to handle cases in the absence of Senior Advocate under his supervision.
- 7) A Certificate from the Managing Partner/Director of the Law Firm certifying that the firm meets all the above criteria along with the profiles of the Partner, Senior Associates and other team members clearly specifying the names of the projects handled.

B. General Information

- 1) The initial appointment of the Law Firm(s) as Standing Counsel(s) will be for a period of two years. Performance of Standing Counsel(s) shall be reviewed on annual basis. However, on completion of the term and satisfactory performance of the Standing Counsel(s), the appointment may be renewed for further period as the Company may decide. RBDCK reserves the right to terminate the appointment at any time.
- 2) Mere submission of Application and fulfilling of eligibility criteria does not entitle the Law Firm for appointment.
- 3) RBDCK reserves the right to modify/relax the eligibility criteria in case sufficient no. of eligible Applications are not received.

- 4) RBDCK reserves the right to summarily reject the Applications for any of the reasons (i) not submitted in the prescribed format or (ii) do not meet any of the eligibility criteria or (iii) not accompanied with requisite documents/information or (iv) incomplete in any respect (v) any other valid reason or without assigning any reasons thereof. \
- 5) RBDCK reserves the right to verify/cross check the information furnished/submitted by the Law Firm.
- 6) The Law Firms may send their presentations giving the background of their Law Firm, experience in handling legal matters of Public Sector Undertakings (giving emphasis to construction sector cases) in soft copy as well as in hard copy in support of information to be furnished in their Application.
- 7) The Standing Counsel shall not advice any party or accept any cases against RBDCK which is likely to affect or lead to litigation against RBDCK.
- 8) The Law Firm shall not take up any case against RBDCK in any Court of Law/ Tribunal / Commission or any appeal or revision arising out of those cases.
- 9) In cases where on the interest of the Government of Kerala have also to be protected, no extra fees shall be paid to the advocate to watch and safeguard the interest of Government of Kerala.
- 10) The Standing Counsel shall obtain prior permission from RBDCK before taking up cases for which legal notices were received by them on a case to case basis. RBDCK may also choose not to avail the services of the Standing Counsel on specific cases at its discretion.
- 11) RBDCK reserves the right to terminate the appointment by giving notice without assigning any reason. The Standing Counsel may also resign by serving 3 month's notice.
- 12) RBDCK would be free to engage any Advocate of its own choice and Standing Counsel shall not make any claim of exclusivity that they should only be entrusted with case.

- (iv) If required, assist Senior Advocates engaged in any particular case before Supreme Court, High Court and other Judicial Bodies.
- (v) Update and inform all development in the designated cases, date of hearing order of the Court and giving his/her/their opinion regarding future course of action against the Judgment / Order
- (vi) Assist the Management with alternative legal strategy for successfully defending the case.
