**NOTICE INVITING TENDERS**

1. Sealed tenders are invited by the Managing Director, Roads and Bridges Development Corporation of Kerala Limited, Palarivattom, Kochi, from eligible contractors registered in Kerala PWD for the work of Urgent BC Repair works at different locations from Bharat Matha College to Puthiya Road Junction in Airport Seaport Road.
2. Tenders should be submitted in the printed ‘tender form’ issued from the office of the officer inviting tenders and website of RBDCK. Tender forms are available from 30.11.2019, 4.30 PM to 06.12.2019, 04:30 PM
3. Tenders sealed and endorsed as such with the name of the work clearly written thereon, should be submitted to the officer inviting tenders before 07.12.2019, 03:30 PM. They will be opened on 07.12.2019, 04:30 PM by the officer inviting tenders or such officer as may be authorized on his behalf in the presence of those Bidders who are present at the time.

## **INSTRUCTIONS TO BIDDERS**

1. Printed tender forms can be obtained from the office of the undersigned and website of RBDCK. Tenders submitted not in such printed forms or tenders, incomplete in any respect such as unattested errors and corrections etc will be liable for summary rejection.
2. No tenders received after the specified last date and time will be accepted on any account
3. Details of the work with item wise specifications are given in the subjoined schedule of work. Bidders must quote only a single rate against each item in the Schedule. The rates quoted shall be inclusive ones covering all the operations contemplated in the schedule of works and all incidental works necessary for such operations. The rate quoted shall not be varied on any account whatever and it shall hold good for all items of work done, irrespective of variations of quantity if any
4. Each Bidder should submit along with the tender a signed copy of document in proof of his registration in Kerala PWD as contractor of the class prescribed in the notice inviting tender.
5. Each tender should be accompanied by the Tender document fee and Earnest Money Deposit of amount mentioned in the notice inviting tender. Both should be produced as Demand Draft on a Scheduled Bank drawn in favour of the officer who has invited tenders. Tenders without EMD will be summarily rejected.
6. In consideration of the Bidder being allowed to quote for the work, he should keep the tender firm for a period of Three months from the last date for the submission of tenders. Withdrawal of tenders before this period will entail forfeiture of EMD for the work.
7. The acceptance of the tender rests with the officer inviting tenders who does not undertake to accept the lowest or any particular tender.
8. The EMD of unsuccessful Bidders will be refunded as soon as possible after tabulating the tenders, keeping the EMD of the first three lowest Bidders. EMD of the remaining unsuccessful Bidders will be refunded within a week of acceptance of the successful bidder.
9. The successful Bidder within Three days of receipt of the selection notice shall deposit an amount which along with the EMD shall make up the total amount equal to 5 % of contract amount. This shall be treated as Performance Security for the proper fulfillment of the work and he shall also execute an agreement for the

work in the standard format. The Performance Security shall be produced as given below

- At least fifty percent of the Performance Security must be in the form of Banker's cheque/bank draft drawn in favor of Roads and Bridges Development Corporation of Kerala Ltd payable at Ernakulam or in the form of treasury fixed deposit and rest in the form of bank guarantee
10. The Security Deposit will be released to the contractor only after the expiry of defects liability period. **Defects liability period is 6 months from the date of completion of work.**
  11. The quantities shown in the schedule are only approximate and are subject to variation and if found necessary the contractor is bound to do additional quantities upto 25% above estimate quantities of each item of work at his quoted rate. If any extra items of work not included in the schedule are executed, its rates will be arrived at on the basis of the rules followed in Kerala PWD.
  12. Time is the essence of the contract. The work shall be completed within 7 days from the date of receipt of written order to commence the work. If the work is not completed by the agreed date liquidated damages will be recovered from the contractor in accordance with the conditions of contract.
  13. Contractor shall appoint qualified engineering representative at site to supervise the work.
  14. The rates quoted by the Contractor shall be deemed to be inclusive of the Sales & other taxes including octroi on all materials that the Contractor will have to purchase for performance of this Contract, BUT EXCLUDING GST @ 12% or as decided by the Government from time to time which will be paid in addition to the quoted rates.
